

NAPA® DREAM VACATION SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE IS NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND ON NUMBER OF ELIGIBLE ENTRIES RECEIVED.

1. Term

The NAPA® Dream Vacation Sweepstakes (the “Sweepstakes”) entry period commences on Tuesday, October 1, 2019 at midnight (12:00:00 a.m.) Eastern Time (“ET”) and will end on Tuesday, December 31, 2019 at 11:59:59 p.m. ET (the “Entry Period”). Sponsor’s computer will serve as the official timeclock for the Entry Period in case of any dispute.

2. Sponsor

This Sweepstakes is sponsored by Trico Products Corporation, 3255 West Hamlin Road, Rochester Hills, MI 48309 (the “Sponsor”). Exotics Racing, the National Automotive Parts Association and The Genuine Parts Company are not sponsors of the Sweepstakes. NAPA® is a registered trademark of the National Automotive Parts Association.

3. Eligibility

The Sweepstakes is open only to legal residents of the fifty United States (excluding New York) and the District of Columbia who have reached the legal age to participate in the Sweepstakes in their State or District of residence and who have internet access. **VOID IN NEW YORK AND WHERE PROHIBITED.** A winner must possess a valid driver’s license in order to redeem racing package portion of prize, will require adequate identification documents in order to travel by air, and be able to complete travel prior to March 31, 2020. Employees, officers and directors of Sponsor, its respective affiliate companies and advertising and promotion agencies, and any other companies involved with the design, production, execution or distribution of this Sweepstakes as well as members of the immediate families (spouses, parents, siblings and children, and each of their respective spouse, regardless of where they reside) or households (whether related or not) of any of the above are NOT eligible to participate. 4. How to Enter

To enter by text entry, Text 72306 to TRICO2019 in store, or Text 72306 to TITAN2019 online. Message and data rates may apply for entry via text message. Alternately, visit tricosweepstakes.com and complete an entry form. Limit one Entry per person; additional entries will be disqualified.

5. Entry Requirements

Entries must be submitted and received during the Entry Period. Proof of submission is not proof of receipt. The Sponsor, its agents and employees are not responsible for the inability of any entrant to complete or continue an Entry due to equipment malfunction, busy lines, inadvertent disconnections, unavailable network, server, Internet Service Provider (ISP) or other connections, communication failures or human error that may occur in the transmission, receipt or processing of Entries, including any injury or damage to any computer arising from or relating to participation in this Sweepstakes. Any use of robotic, macro, automatic, programmed or like Entry methods will void all such Entries, and may subject that Entrant to disqualification. Sponsor, its agents and employees are not responsible for late, lost, misdirected, mutilated, illegible or incomplete Entries. By entering, entrants acknowledge compliance with these Official Rules, including without limitation all eligibility requirements, and agree to be bound by all terms of the Official Rules.

Sponsor reserves the right to examine all Entries and source material therefrom in order to confirm compliance with these Official Rules. Any Entry that, in the Sponsor's sole and absolute discretion, does not comply with these Official Rules will be disqualified from the Sweepstakes.

The package consists of the following: Exotic Racing Experience for you and a guest (provided in the form of 2 \$1,000 vouchers for Exotics Racing Las Vegas), 4 nights stay in a double occupancy hotel room selected by Sponsor, round- trip coach airfare for two from airport convenient to winner (as mutually agreed by Sponsor and Winner), ground transportation to/from race experience, and up to \$5,000 in spending money (provided in the form of VISA gift cards). Calculation for spending money will be to subtract sponsor's expenses for other components of Prize from \$10,000; remainder will be provided to Winner. If Winner resides within a 100-mile radius of the destination, ground transportation may be provided in lieu of air transportation and no compensation or

7. Winner Determination and Notification

The Potential Winner of the Sweepstakes will be randomly selected from among all eligible valid Entries received during the Entry Period by Sponsor or its agent on or about January 15, 2020 (the "Drawing Date") and must complete verification process to be declared Winner. Potential Winner shall be notified using the phone number of entry, or if available, by email and by United States Mail, using the numbers and/or addresses provided in the Entry, within five (5) days after the drawing. Should Potential Winner fail to respond to the Prize notification, be disqualified or reject or waive the Prize for any reason, or if email notification is returned as undeliverable, a new Winner shall be selected by Sponsor by random drawing from the remaining eligible Entrants.

8. Winner Requirements and Prize Delivery

Upon responding to the Sponsor's notification, Winner will be required to complete and return a Winner's Agreement confirming his or her eligibility for the Sweepstakes, accepting all terms of these Official Rules, and will be required to furnish his or her Social Security number. An IRS form 1099-MISC will be issued to Winner reflecting the value of the Prize. Winner must return an executed Winner's Agreement to Sponsor within five (5) business days of receipt of such agreement to remain eligible to receive the Prize. Upon the receipt of such executed Winner's Agreement, Winner and Sponsor or Sponsor's agent will mutually agree upon a means for Winner to receive the Prize.
